## Committee Nomination Form

The Alcohol and Other Drug Consumer & Community Coalition ,or 'AOD triple C', was incorporated in July 2018. Nominations from members to fill committee positions are now being accepted and elections for all positions will be held at our first **AGM** on **Thursday, 1st November, 2018**. 'The committee members are the persons who, as the management committee of the Association, have the power to manage the affairs of the Association'.

Committee members have duties and responsibilities under the Associations Incorporation Act 2015 in relation to their role. Essentially, these duties require a committee member to act in good faith, not for personal gain and in the interests of the association. Because of these duties, members nominating for a committee position are required to be 18 or over, have full membership status and, under <u>Section 39</u> of the Act, be 'able to be members of a committee'. This relates to not currently being under insolvency and not having recent charges of dishonesty or misconduct as a committee member of an association.

Nominations are required 28 days before the AGM, by close of business **Wednesday**, **3rd October 2018** and names of all nominees will be circulated to members 21 days prior to the AGM. During the election process nominees may be required to address the AGM regarding their nomination.
