As per the monthly meeting of the AODCCC Board on the 5th of August:

- 1. **Independent Bookkeeper** One of our main priorities has been to establish secure financial processes for which we have successfully contracted an independent bookkeeper. The bookkeeper will work with the Treasurer and the Project Lead to ensure all financial reporting needs and requirements are met.
- Hosting arrangement with the HCC The Health Consumers' Council (HCC) will be hosting the AODCCC during the period of our establishment by providing mentorship, supervision and organisational guidance which has now been formalised by a Memorandum of Understanding between the HCC and the AODCCC. This document will be posted to the HCC website.
- 3. **Project Lead** A fixed, six-month, part-time position of Project Lead has now been formalised with an Employment Contract and Duties Statement.
- 4. **New Board members** We have welcomed two new Board members. David Shakespeare, previously our Secretary, has returned to the Board and Caroline Henson joins us for the first time.
- 5. **Appointment of Treasurer** Caroline Henson was nominated and accepted the role of Treasurer.
- 6. **Governance training** Governance training for Board members is planned for late this month.
- 7. **Communication** Now that the role of Project Lead is implemented, all communication to the Board will be managed and distributed to the Board as necessary by the Secretary, Grant Smith.

Many of our members attended our consultations or answered the survey in order for us to make a successful submission to the recent parliamentary inquiry 'alternate approaches to reducing illicit drug use and its effects on the community'.
